8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The San Francisco Park Code is hereby amended by amending Sec. 4.10  
10 to read as follows:

11 SEC. 4.10. ALCOHOLIC BEVERAGES.

12 (a) No person shall consume alcoholic beverages of any kind in any building,  
13 children's playground, swimming pool, restroom, or any of the parks or portions of parks as  
14 follows, except with the permission of the Recreation and Park Department.

6 use and enjoyment of the park.


