 19 Controller is authorized to increase or decrease the final budgetary allocation of parking tax
 20 in-lieu transfers to reflect actual collections. The Municipal Transportation Agency must obtain
 21 Board of Supervisors' approval prior to any expenditure supported by allocations that accrue
 22 to the Agency that are greater than those already appropriated in the AAO.






