12 Section 1. The City Attorney is hereby authorized to settle the action entitled "Hattie

14 Dan Gilman, and Michael Saldanha", United States District Court for the Northern District of

15 California, Case No. 06-1067, by payment of \$70,000.00. The sum shall be allocated by

16 means of two checks made payable as follows: a) to "Hattie Finn-Carter" in the sum of


17 \$36,262.10 for general damages, and b) to the "Law Offices of Fania E. Davis" in the sum of




