9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. On October 19, 2005, Mayor Gavin Newsom established a reward of  
11 \$25,000 for information leading to the arrest and conviction of the person responsible for the  
12 shooting deaths of twenty-two-year-old Derna Wysinger and his two-year-old son, Naemon  
13 Wysinger, on October 14, 2005. A John Doe came forward and supplied information leading  
14 to the arrest and conviction of Joseph Stevens for these crimes. Joseph Stevens has been  
15 convicted by a jury of two counts of murder, including Special Circumstances, in the shooting  
16 deaths of Derna and Naemon Wysinger, as well as other related offenses.

17 Section 2. The Controller of the City and County of San Francisco is hereby authorized  
18 to draft warrants upon the Treasury of the City and County of San Francisco totaling Twenty-  
19 Five Thousand Dollars (\$25,000) to be paid to the John Doe who supplied the information  
20 leading to the arrest and conviction of Joseph Stevens for the shooting deaths of Derna and  
21 Naemon Wysinger.
