14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. The City Attorney is hereby authorized to settle the case with Northwest

16 Airlines Corporation called In re Northwest Airlines Corporation, et al., Debtors, Case No. 05-

17 17930ALG United States Bankruptcy Court for the Southern District of New York and a

18 related litigated claim with regard to City and County of San Francisco v. ARCO et al., Case

19 No. C-97-2965 MMC (N.D. Cal) on the terms and conditions specified in that certain Cure

20 Stipulation on file with Clerk of the Board (file no. 070766);

21 Section 2. The Cure Stipulation and the actions contemplated thereby are hereby

22 approved.

23 Section 3. The material terms of the Cure Stipulation include but are not limited to

24 Northwest Airlines Corporation ("Northwest Airlines") payment to the San Francisco

25 International Airport ("Airport") of One Million Sixty-Nine Thousand Five Hundred Six Dollars

1 and Twenty-Four Cents (\$1,069,506.24) in full and final satisfaction of Northwest Airlines'
2 obligation to cure all defaults under their Airport lease agreements; Northwest Airlines
3 payment of One Hundred Eighteen Thousand Thirty Dollars and Twenty Cents (\$118,030.20)
4 for past environmental clean-up costs and agreement to assume a percentage allocation of
5 future environmental clean-up costs.

6 Section 4. That the Airport Director be and hereby is authorized to take such other
7 actions as are necessary and appropriate in furtherance of this ordinance, including the
8 execution of agreement(s) and modifications contemplated by the Cure Stipulation, provided
9 such agreement(s) are approved as to form by the City Attorney.


