10 will become the administrator of the Workforce Investment Act (WIA)
11 local area; and,

12 WHEREAS, the current WIA administrator, the PIC, will be
13 dissolved on June 30, 2007 and will no longer provide WIA fiscal and
14 programmatic services; and,

15 WHEREAS, Economic and Workforce Development will assume
16 responsibility for workforce development administration, contracting,
17 and data management; and,

18 WHEREAS, The grant terms prohibit including indirect costs in
19 the grant budget; now, therefore, be it

20 ORDAINED, That the Board of Supervisors hereby waives inclusion
21 of indirect costs in the grant budget; and be it

22 FURTHER ORDAINED, That the Annual Salary Ordinance is hereby
