8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Findings.

10 The Planning Department has determined that the actions contemplated in this
11 Ordinance are in compliance with the California Environmental Quality Act (California Public
12 Resources Code sections 21000 et seq.).

13 Section 2. The San Francisco Park Code is hereby amended by adding Section 12.45,
14 to read as follows:

15 **SEC. 12.45. RESERVATION ADMINISTRATIVE FEES.**

16 *The following administrative fees are applicable to all reservations for Recreation and Park*
17 *Department programs, activities and facilities, unless otherwise specified:*


18 *(a) A refund processing fee of \$10.00 or 20% of the fee, whichever is greater, will be*
19 *charged when a person requests a refund of program fees.*

20 *(b) A program withdrawal fee of \$10.00 or 20% of the fee, whichever is greater, will be*
21 *charged when a person withdraws from a program or activity.*

22 *(c) There will be a cancellation fee of \$20.00 or 20% of the rental fee, whichever is greater,*
23 *for the cancellation of facility rental reservations.*

24 *(d) There will be a non-refundable application fee of \$50.00 for special event permits.*


