9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Findings.

11 The Planning Department has determined that the actions contemplated in this
12 Ordinance are in compliance with the California Environmental Quality Act (California Public
13 Resources Code sections 21000 et seq.).

14 Section 2. The San Francisco Park Code is hereby amended by amending Section
15 12.32, to read as follows:

16 **SEC. 12.32. RESIDENT GOLF CARDS.**

17 (a) An annual fee of ~~\$40.00~~ \$45.00 shall be charged for San Francisco Resident
18 Golf Cards, entitling the holder to discounts on the golf courses under the jurisdiction of the
19 Recreation and Park Department. Cards shall be available to San Francisco residents only.

20 (b) An annual fee of \$30 shall be charged to Pacifica residents for a Pacifica Resident Card
21 for use at Sharp Park for Fiscal Year 2007-2008. The fee will increase to \$45.00 in Fiscal Year 2008-
22 2009.

23 (c) A fee of \$25.00 shall be charged for replacement of San Francisco and Pacifica
24 Resident Golf Cards.

1 (d) If a San Francisco or Pacifica resident card application is returned to the applicant
2 because the information on the application is incorrect or incomplete, there shall be an additional
3 administrative fee of \$5.00.


