

1 [Penalty for Removing Chalk Marks.]

2 **Ordinance amending San Francisco Traffic Code Sections 21 and 132 to impose a**  
3 **penalty for removing chalk marks of one hundred (\$100) dollars for any violation and to**  
4 **make minor changes to clarify the parking restriction.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The San Francisco Traffic Code is hereby amended by amending Section  
10 21, to read as follows:

11 **SEC. 21. REMOVAL OF CHALK MARKS.**

12 The owner or operator of any ~~motor~~-vehicle ~~exercising the privilege of parking said~~who  
13 parks such vehicle on any street ~~or portion thereof~~ where ~~time restrictions~~regulations are in effect  
14 ~~restricting the length of time said vehicle may be parked on said street or portion thereof~~ does so on  
15 the condition that ~~the Police Officers or Parking Control Officers of the~~City and County employees  
16 may place chalk or other removable marks on the tires of said vehicle for the purpose of  
17 enforcing ~~such~~ parking regulations.

18 It shall be unlawful for any person to erase, rub out, or otherwise remove or conceal,  
19 any chalk or other mark ~~so~~ placed by a City and County employee ~~Police Officer or a Parking~~  
20 ~~Control Officer~~ while the vehicle remains parked on the ~~said street or portion thereof~~.

21 ~~Any person violating the provisions of this Section shall be guilty of an infraction and upon~~  
22 ~~conviction thereof shall be punished by a fine of not less than \$5 or more than \$50.~~

23 Section 2. The San Francisco Traffic Code is hereby amended by amending Section  
24 132, to read as follows:

25 **SEC. 132. PENALTY SCHEDULE.**

Pursuant to California Vehicle Code Section 40203.5, violation of any of the following subsections of the San Francisco Traffic Code (TC), Police Code (PC) or the California Vehicle Code (VC) shall be punishable by the fines set forth below.


