2 Salary Ordinance, FY 2007-2008.]

3 **Ordinance authorizing the Department of Emergency Management, as fiscal agent for**
4 **multiple local jurisdictions, to retroactively accept and expend a Community Oriented**
5 **Policing Services (COPS) grant in the amount of \$5,733,986 from the United States**
6 **Department of Justice and to provide \$406,002 as San Francisco's portion of required**
7 **matching funds; and amending Ordinance No. 175-07 (Annual Salary Ordinance, FY**
8 **2007-2008) to reflect the addition of one position (0.75 FTE) IS Project Director in the**
9 **Department of Emergency Management (ECD).**

14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. Findings. The United States Department of Justice, through its Community
16 Oriented Policing Services (COPS) Grant Program, provides funds to local, state, and tribal
17 law enforcement agencies to procure technology to share data information and enhance voice
18 interoperability with regional, state, and federal partners, with the goal of increasing public
19 safety. The Department of Justice provides 75 percent of the total grant funds awarded, and
20 grant recipients must contribute the remaining 25 percent of the funds.

21 The City and County of San Francisco, together with its regional partners the City of
22 Oakland and the Counties of Alameda, Contra Costa, and San Mateo (collectively with San
23 Francisco, the "partner jurisdictions"), has received a total grant award of \$7,645,314 from the
24 COPS Grant Program, to hire a project manager and purchase equipment that will enhance
25 interoperable communications and information sharing among the partner jurisdictions, and

1 benefit all recipient jurisdictions. The Department of Justice will provide \$5,733,986 of the
2 grant funds for the award, and the partner jurisdictions must provide \$1,911,328 in matching
3 funds. Each partner jurisdiction will provide a portion of the matching funds, based on its
4 share of the total award. San Francisco must provide \$406,002 as its portion of the required
5 matching funds. The grant period is from September 1, 2007 to August 31, 2010.

6 Under the grant and with the agreement of all partner jurisdictions, San Francisco is
7 designated as the fiscal agent for the partner jurisdictions, for receipt and expenditure of the
8 grant funds.

9
10 Section 2. Authorization to Accept and Expend Grant Funds. The Board of
11 Supervisors hereby authorizes the Department of Emergency Management to retroactively
12 accept and expend, as fiscal agent, on behalf of the City and County of San Francisco, the
13 City of Oakland, and the Counties of Alameda, Contra Costa, and San Mateo, \$5,733,986
14 from the COPS Grant Program, and to provide \$406,002 in matching funds, which represents
15 San Francisco's portion of the \$1,911,328 in matching funds required under the grant. The
16 grant does not include any provisions for indirect costs, and indirect costs are hereby waived.

17 The Executive Director of the Department of Emergency Management, or designee, is
18 authorized to enter into a Memorandum of Understanding with the City of Oakland and the
19 Counties of Alameda, Contra Costa, and San Mateo, on behalf of the City and County of San
20 Francisco, to govern application, acceptance, allocation, distribution and any other actions
21 related to the COPS grant. The Executive Director of the Department of Emergency
22 Management, or designee, is further authorized to furnish whatever additional information or
23 assurances the Department of Justice may request in connection with the grant, to execute

1 any and all agreements or other documents, and to take any other steps necessary to accept,
2 distribute and expend the grant funds.

4 Section 3. Grant Funded Position; Amendment to FY 2007-2008 Annual Salary
5 Ordinance. The hereinafter designated section and item of Ordinance No. 175-07 (Annual
6 Salary Ordinance, FY 2007-2008) is hereby amended so that it reads as follows:




