14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. Findings.

16 A. On _____, at a duly noticed public hearing, the Planning
17 Commission in Motion No. _____ found that the proposed zoning reclassification
18 and map amendment were consistent with the City's General Plan and with Planning Code
19 Section 101.1(b). In addition, the Planning Commission, in Resolution No. _____,
20 recommended that the Board of Supervisors adopt the zoning map amendment. Copies of
21 said Resolution and Motion are on file with the Clerk of the Board of Supervisors in File No.
22 _____ and are incorporated herein by reference. The Board finds that the proposed
23 zoning reclassification and map amendment are consistent with the City's General Plan and
24 with Planning Code Section 101.1(b) for the reasons set forth in said Resolution and Motion.

25 B. Pursuant to Planning Code Section 302, the Board finds that the proposed
zoning reclassification and map amendment will serve the public necessity, convenience and

1 welfare for the reasons set forth in Planning Commission Resolution No. _____,
2 which reasons are incorporated herein by reference as though fully set forth.

3 C. The Planning Department has determined that the actions contemplated in this
4 Ordinance are in compliance with the California Environmental Quality Act (California Public
5 Resources Code section 21000 et seq.). Said determination is on file with the Clerk of the
6 Board of Supervisors in File No. _____ and is incorporated herein by reference.

7 Section 2. In accordance with Planning Code Sections 106 and 302, the following
8 changes are hereby adopted as amendments to Zoning Map ZN 12 of the Zoning Map of the
9 City and County of San Francisco:
