11 payment of \$45,000, and excluding the claim by this plaintiff for attorney's fees, costs and
12 interest, which will be addressed in later proceedings.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiff
15 Noreen Quimson and Defendant City and County of San Francisco.


