

1 [Re-establishing the name of the Richmond District.]

2 **Ordinance rescinding Ordinance 4397 and re-establishing the name of the area north of**
3 **Golden Gate Park and west of Arguello Boulevard as the Richmond District.**

5 Be it ordained by the People of the City and County of San Francisco:

6 Section 1. Findings. The Board of Supervisors named the area north of Golden Gate
7 Park and west of First Avenue the Richmond District on November 24, 1890. In 1917,
8 improvement clubs in the Richmond District petitioned the Board of Supervisors to change the
9 name of the district to Park-Presidio District, to distinguish this neighborhood from the City of
10 Richmond in Contra Costa County. On November 26, 1917 the Board of Supervisors re-
11 named the area north of Golden Gate Park and west of First Avenue as the "Park Presidio
12 District" by Ordinance 4397. The name "Park Presidio District" never became popular with
13 the public or perpetuated by City and County use. The area has never been known or referred
14 to as the "Park Presidio District" but has been known and referred to as the Richmond District.
15 This correction of the public record of the Board of Supervisors would have no fiscal impact or
16 need for change of any current designation of the district. The Board of Supervisors seeks to
17 clarify the official name of the area as the Richmond District.

18 Section 2. The Board of Supervisors hereby rescinds Ordinance 4397 and establishes
19 the name of the area north of Golden Gate Park and west of Arguello Boulevard as the
20 Richmond District.


