9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Findings.

11 The Planning Department has determined that the actions contemplated in this
12 Ordinance are in compliance with the California Environmental Quality Act (California Public
13 Resources Code sections 21000 et. seq.). Said determination is on file with the Clerk of the
14 Board of Supervisors in File No. 090720 and is incorporated herein by reference.

15 Section 2. The San Francisco Park Code is hereby amended by Section 12.34, to read as
16 follows:

17 **SEC. 12.34. CONSERVATORY OF FLOWERS FEES.**

18 (a) Admission Fees. The following fees shall be charged for admission to the
19 Conservatory of Flowers:

5 (b) In addition, the Conservatory of Flowers will be open without charge one day each month
6 and on sponsored special event days.


