11 Baker, by the payment of \$190,000, and excluding the claim by these plaintiffs for diminution  
12 of property value, attorney's fees, costs and interest, which will be addressed in later  
13 proceedings.


14 Section 2. The above-named action was filed in San Francisco Superior Court on


