8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The San Francisco Park Code is hereby amended by amending Section
10 7.21 to read as follows:

11 SEC. 7.21. FARMERS' MARKETS.

12 (a) The Commission may permit the location of a Farmers' Market, that meets the
13 requirements of Administrative Code Chapter 9A. or any successor provisions, as certified by
14 the Agricultural Commissioner, on park land upon findings that such a use:

15 (1) Is appropriate for the crowd capacity of the particular location;

16 (2) Does not adversely affect park grounds or facilities beyond the regular usage of the
17 particular location; and,

18 (3) Does not significantly interfere with the public's use and enjoyment of other areas
19 of the park, including, but not limited to, children's play areas or athletic courts or fields.

20 (b) The permit fee shall be ~~at least \$50.00 per stall per day, \$475 per location of market,~~
21 held once a week, for six (6) months of operation, plus reimbursement for staff costs directly incurred
22 by the operation of the market.




