

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. On February 18, 2004, Mayor Newsom established a reward fund of  
11 \$10,000 to be paid to any individual or individuals supplying information leading to the arrest  
12 and conviction of the person or persons responsible for the deaths of Jovanie Banks and  
13 Michael Hill. During the course of the investigation of these deaths, a witness came forward  
14 with information leading to the arrest and conviction of Emile Forte in federal district court for  
15 the murders of Jovanie Banks and Michael Hill. In the middle of his trial, Emile Forte pled  
16 guilty and received a sentence of 41 plus years for the murders.

17 Section 2. The Controller of the City and County of San Francisco is hereby authorized  
18 to draft warrants upon the Treasury of the City and County of San Francisco totaling Ten  
19 Thousand Dollars (\$10,000) to be paid to the John Doe who supplied the information leading  
20 to the arrest and conviction of Emile Forte for the deaths of Jovanie Banks and Michael Hill.
