10 Superior Court, Court No. 436930, as it relates only to plaintiff Victoria Sanchez, by the  
11 payment of \$66,500, and excluding the claim by this plaintiff for diminution of property value,  
12 attorney's fees, costs and interest, which will be addressed in later proceedings.

13 Section 2. The above-named action was filed in San Francisco Superior Court on  
14 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiff  
15 Victoria Sanchez and Defendant City and County of San Francisco.




