12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Findings.

14 (a) On July 1, 2011, the Department of Public Works began implementation of a
15 new organization structure of the Public Works Engineering Division.

16 (b) The goal of the reorganization is to realign and restructure the Division's internal
17 resources to create integrated project teams capable of providing complete planning, design,
18 and constructions management services to achieve high quality, consistent, and more efficient
19 delivery of capital projects.

20 (c) As part of this reorganization, the Department of Public Works merged the
21 Bureau of Architecture, Bureau of Engineering, Bureau of Project Management, and Bureau
22 of Construction Management together to create two integrated divisions, namely Building
23 Design & Construction and Infrastructure Design & Construction.

1 Section 2. The San Francisco Administrative Code is hereby amended by amending
2 Section 2A.190, to read as follows:

3 **SEC. 2A.190. DEPARTMENT OF PUBLIC WORKS.**

4 (a) The Department of Public Works shall administer all capital improvement and
5 construction projects, except projects solely under the Airport, Port, Public Utilities, Recreation
6 and Park and Public Transportation Commissions.

7 (b) All examinations, plans, estimates and construction administration services
8 required by the City and County in connection with any public improvements, exclusive of
9 those made by the Airport, Port, Public Utilities, Recreation and Park and Public
10 Transportation Commissions, shall be made by the Director of Public Works, and the Director
11 shall, when requested to do so, furnish information and data for the use of the Board of
12 Supervisors.

13 (c) The Director of Public Works shall designate a deputy or other employee as City
14 Engineer. The City Engineer shall possess the same power in the City and County as is or
15 may from time to time be given by law to city engineers, and the official acts of the City
16 Engineer shall have the same validity and be of the same force and effect as are or may be
17 given by law to those of city engineers.

18 (d) The Director of Public Works shall designate a deputy or other employee as
19 County Surveyor. The County Surveyor shall possess the same power in the City and County
20 in making surveys, plats and certificates as is or may from time to time be given by law to
21 county surveyors, and the official acts and all plats, surveys and certificates of the County
22 Surveyor shall have the same validity and be of the same force and effect as are or may be
23 given by law to those of county surveyors.

1 (e) Any and all references to the "Bureau of Architecture," "Bureau of Engineering," or
2 "Bureau of Construction Management" in the San Francisco Municipal Code is deemed to be a
3 reference to the "Department of Public Works."
