10 Section 1. The San Francisco Administrative Code is hereby amended by amending
11 Section 16.703, to read as follows:

12 Sec. 16.703 HEALTH SERVICE SYSTEM; PLAN AND CONTRIBUTION RATES.

14 plans of the Health Service System, to become effective on ~~July 1, 2012~~January 1, 2013 for the
15 ~~six-month plan-calendar plan~~ year ~~July 1, 2012~~January 1, 2013 through ~~December 31, 2012,~~
16 ~~December 31, 2013,~~ approved by the Health Service Board in actions taken by it on ~~January 12,~~
17 ~~2012~~ April 12, 2012, May 10, 2012, June 1, 2012, June 14, 2012 and July 3, 2012, which plans and
18 contribution rates are on file with the Clerk of the Board of Supervisors, are hereby approved,
19 ~~provided that, in response to the recommendation of the Executive Director of the Health Service~~
20 ~~System, the Board approves the Vision Buy Up Plan so long as it contains a provision that makes its~~
21 ~~implementation subject to the Controller's determination that the City is administratively able to do so.~~
