

1 [Planning Code, Zoning Map - Establishing the Fillmore Street Neighborhood Commercial
2 District]

3 **Ordinance amending the Planning Code to establish the Fillmore Street Neighborhood**
4 **Commercial District along Fillmore Street between Bush and McAllister Streets;**
5 **amending various other Code sections to make conforming and other technical**
6 **changes; amending the Zoning Map to add the Fillmore Street NCD; affirming the**
7 **Planning Department's California Environmental Quality Act determination; and making**
8 **findings of consistency with the General Plan, and the eight priority policies of**
9 **Planning Code, Section 101.1.**

17 Be it ordained by the People of the City and County of San Francisco:

18 Section 1. Findings.

19 (a) The Planning Department has determined that the actions contemplated in this
20 ordinance comply with the California Environmental Quality Act (California Public Resources
21 Code Section 21000 et seq.). The Board of Supervisors hereby affirms this determination.
22 Said determination is on file with the Clerk of the Board of Supervisors in File No. 120814 and
23 is incorporated herein by reference.

24 (b) On June 13, 2013, the Planning Commission, in Resolution No. 18907, adopted
25 findings that the actions contemplated in this ordinance are consistent, on balance, with the
City's General Plan and the priority policies of Planning Code Section 101.1. The Board

1 adopts these findings as its own. A copy of said Resolution is on file with the Clerk of the
2 Board of Supervisors in File No. 120814.

3
4 Section 2. The Planning Code is hereby amended by adding Section 747.1 and the
5 accompanying Zoning Control Table, to read as follows:

6 **SEC. 747.1. FILLMORE STREET NEIGHBORHOOD COMMERCIAL DISTRICT.**

7 *The Fillmore Street Neighborhood Commercial District ("Fillmore Street NCD") extends along*
8 *Fillmore Street between Bush and McAllister Streets. Fillmore Street's dense mixed-use character*
9 *consists of buildings with residential units above ground-story commercial use. Buildings range in*
10 *height from one-story commercial buildings to high-rise towers. Fillmore Street and Geary Boulevard*
11 *are important public transit corridors. The commercial district provides convenience goods and*
12 *services to the surrounding neighborhoods as well as shopping, cultural, and entertainment uses that*
13 *attract visitors from near and far.*

14 *The Fillmore Street NCD controls are designed to encourage and promote development that*
15 *enhances the walkable, mixed-use character of the corridor and surrounding neighborhoods. Rear yard*
16 *requirements at residential levels preserve open space corridors of interior blocks. Housing*
17 *development in new buildings is encouraged above the ground story. Existing residential units are*
18 *protected by limitations on demolition and upper-story conversions.*

19 *Consistent with Fillmore Street's existing mixed-use character, new commercial development is*
20 *permitted at the ground and second stories. Most neighborhood- and visitor-serving businesses are*
21 *strongly encouraged. Controls on new Formula Retail uses are consistent with Citywide policy for*
22 *Neighborhood Commercial Districts; Eating and Drinking and entertainment uses are confined to the*
23 *ground story. The second story may be used by some retail stores, personal services, and medical,*
24 *business, and professional offices. Parking and hotels are monitored at all stories. Limits on drive-up*

1 facilities and other automobile uses protect the livability within and around the district and promote
 2 continuous retail frontage.

4 (e) **General Advertising Signs.** General advertising signs, as defined in Section
5 602.7, shall, where permitted by the zoning controls for the individual NC districts, conform to the
6 requirements of this subsection be permitted in Neighborhood Commercial Districts, except in the
7 Inner Sunset Neighborhood Commercial District where they are not permitted, as provided for below.

8 In NC Districts where such signs are permitted, general advertising signs may be either a wall
9 sign or freestanding, provided that the surface of any freestanding sign shall be parallel to and
10 within three feet of an adjacent building wall. In either case, the building wall shall form a
11 complete backdrop for the sign, as the sign is viewed from all points from a street or alley from
12 which it is legible. No general advertising sign shall be permitted to cover part or all of any
13 windows. Any extension of the copy beyond the rectangular perimeter of the sign shall be
14 included in the calculation of the sign, as defined in Section 602.1(a) of this Code.

15 (1) NC-2, NCT-2, ~~and~~ NC-S, and named NC and NCT Districts. No more than one
16 general advertising sign shall be permitted per lot or in NC-S Districts, per district. Such sign
17 shall not exceed 72 square feet in area nor exceed 12 feet in height. Such sign may be either
18 nonilluminated or indirectly illuminated.

19 (2) NC-3, and NCT-3, ~~and~~ Broadway Districts. No more than one general
20 advertising sign not exceeding 300 square feet or two general advertising signs of 72 square
21 feet each shall be permitted per lot. The height of any such sign shall not exceed 24 feet, or
22 the height of the wall to which it is attached, or the height of the lowest of any residential
23 windowsills on the wall to which it is attached, whichever is lower, if a wall sign, or the
24 adjacent wall or the top of the adjacent wall if a freestanding sign, whichever is lower.

1 (f) **Business Signs.** Business signs, as defined in Section 602.3 shall be permitted in
2 all Neighborhood Commercial and Residential-Commercial Districts subject to the limits set
3 forth below.

12 Neighborhood Commercial Districts.

13 (A) **Window Signs.** The total area of all window signs, as defined in
14 Section 602.1(b), shall not exceed 1/3 the area of the window on or in which the signs are
15 located. Such signs may be nonilluminated, indirectly illuminated, or directly illuminated.

16 (B) **Wall Signs.** The area of all wall signs shall not exceed two square
17 feet per foot of street frontage occupied by the use measured along the wall to which the
18 signs are attached, or 100 square feet for each street frontage, whichever is less. The height
19 of any wall sign shall not exceed 24 feet, or the height of the wall to which it is attached, or the
20 height of the lowest of any residential windowsill on the wall to which the sign is attached,
21 whichever is lower. Such signs may be nonilluminated, indirectly, or directly illuminated.

22 (C) **Projecting Signs.** The number of projecting signs shall not exceed
23 one per business. The area of such sign, as defined in Section 602.1(a), shall not exceed 24
24 square feet. The height of such sign shall not exceed 24 feet, or the height of the wall to which
25 it is attached, or the height of the lowest of any residential windowsill on the wall to which the

1 sign is attached, whichever is lower. No part of the sign shall project more than 75 percent of
2 the horizontal distance from the street property line to the curblineline, or six feet six inches,
3 whichever is less. Such signs may be nonilluminated or indirectly illuminated; or during
4 business hours, may be directly illuminated.

5 (D) **Signs on Awnings and Marquees.** Sign copy may be located on
6 permitted awnings or marquees in lieu of projecting signs. The area of such sign copy as
7 defined in Section 602.1(c) shall not exceed 30 square feet. Such sign copy may be
8 nonilluminated or indirectly illuminated; except that sign copy on marquees for movie theaters
9 or places of entertainment may be directly illuminated during business hours.

10 (E) **Freestanding Signs and Sign Towers.** With the exception of
11 automotive gas and service stations, which are regulated under Paragraph 607.1(f)(4), one
12 freestanding sign or sign tower per lot shall be permitted in lieu of a projecting sign, if the
13 building or buildings are recessed from the street property line. The existence of a
14 freestanding business sign shall preclude the erection of a freestanding identifying sign on the
15 same lot. The area of such freestanding sign or sign tower, as defined in Section 602.1(a),
16 shall not exceed 20 square feet nor shall the height of the sign exceed 24 feet. No part of the
17 sign shall project more than 75 percent of the horizontal distance from the street property line
18 to the curblineline, or six feet, whichever is less. Such signs may be nonilluminated or indirectly
19 illuminated; or during business hours, may be directly illuminated.

21 **SEC. 702.1. NEIGHBORHOOD COMMERCIAL USE DISTRICTS.**

22 (a) The following districts are established for the purpose of implementing the
23 Commerce and Industry element and other elements of the General Plan, according to the
24 objective and policies stated therein. Description and Purpose Statements outline the main
25

1 functions of each Neighborhood Commercial (NC) District in the Zoning Plan for San
 2 Francisco, supplementing the statements of purpose contained in Section 101 of this Code.

3 The description and purpose statements and land use controls applicable to each
 4 of the general and individual area districts are set forth in this Code for each district class. The
 5 boundaries of the various Neighborhood Commercial Districts are shown on the Zoning Map
 6 referred to in Sections 105 and 106 of this Code, subject to the provisions of that Section.


