2 ADDING SECTION 32.6.23 TO THE SAN FRANCISCO TRAFFIC CODE, REGARDING  
3 PARKING REGULATIONS ON A PORTION OF 6<sup>th</sup> AVENUE.

4 Note: This entire section is new.


5 Be it ordained by the people of the City and County of San Francisco:

6 Section 1. Article 3 of the San Francisco Traffic Code is hereby amended by adding  
7 Section 32.6.23 thereto to read as follows:

8 **SEC. 32.6.23. PARKING CONTROL, PORTION OF 6<sup>th</sup> AVENUE; PENALTIES FOR**  
9 **VIOLATION.** No person shall stop, park, or leave standing any vehicle, whether attended or  
10 unattended, on the east side of 6<sup>th</sup> Avenue, from 272 feet to 334 feet south of Geary Boulevard  
11 (62-foot zone), except official City-owned vehicles displaying a valid permit issued by the San  
12 Francisco Police Department authorizing parking in such zones. The permit exceptions under  
13 this Section shall not apply when parking prohibition regulations for street-cleaning purposes  
14 are in effect. Violation of this Section is an obstruction to the free use of property and a  
15 nuisance within the meaning of Division 4, Part III of the Civil Code of California relating to  
16 nuisance and the abatement thereof.




