

1 [Memorandum of Understanding]
2 IMPLEMENTING THE PROVISIONS OF AN AMENDMENT TO SECTION 16 (BENEFITS
3 FOR PART-TIME OPERATORS) OF THE MEMORANDUM OF UNDERSTANDING
4 BETWEEN THE TRANSPORT WORKERS UNION LOCAL 250A (CLASSIFICATION 9163
5 AND RELATED TRAINEE CLASSIFICATIONS), TO PROVIDE A MAXIMUM AMOUNT OF
6 \$225 PER MONTH TOWARD DEPENDENT HEALTH CARE COVERAGE FOR
7 PERMANENT PART-TIME EMPLOYEES WHO REGULARLY WORK A MINIMUM OF
8 TWENTY HOURS PER PAYROLL PERIOD AND UPON COMPLETION OF ONE YEAR OF
9 CONTINUOUS SERVICE, AND TO PROVIDE THAT THE CITY WILL PICK UP THE
10 EMPLOYEE'S SHARE OF CONTRIBUTION TO THE APPLICABLE SFERS RETIREMENT
11 PLAN FOR PERMANENT PART-TIME EMPLOYEES AT A RATE OF: 2.5% FOLLOWING
12 ONE DAY TO SIX MONTHS OF CONTINUOUS SERVICE; 5% FOLLOWING SIX MONTHS
13 TO ONE YEAR OF CONTINUOUS SERVICE; AND 7.5% FOLLOWING ONE YEAR OF
14 CONTINUOUS SERVICE.

15 Be it ordained by the People of the City and County of San Francisco:

16 Section 1. The Board of Supervisors hereby implements the provisions of an
17 amendment to Section 16 (Benefits for Part-Time Operators) of the Memorandum of
18 Understanding between the Transport Workers Union Local 250A (Classification 9163 and
19 related Trainee Classifications), to provide a maximum amount of \$225 per month toward
20 dependent health care coverage for permanent part-time employees who regularly work a
21 minimum of twenty hours per payroll period and upon completion of one year of continuous
22 service, and to provide that the City will pick up the employee's share of contribution to the
23 applicable SFERS retirement plan for permanent part-time employees at a rate of: 2.5%
24 following one day to six months of continuous service; 5% following six months to one year of

1 continuous service; and 7.5% following one year of continuous service. The provisions so
2 implemented are on file in the office of the Board of Supervisors.


