
8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The San Francisco Administrative Code is hereby amended by amending
 10 Section 1.41, to read as follows:

11 Sec. 1.41 Hold Harmless Agreements Between The Department Of Parking And
 12 Traffic And Governmental Entities For Receipt Of Transportation Grant Funds. The
 13 Department of Parking and Traffic and the Department of Public Works are ((is)) hereby
 14 authorized to enter into hold harmless agreements, approved as to form by the City Attorney,
 15 with state and federal governmental entities for the purpose of obtaining transportation grant
 16 funds from such entities to pay the costs of transportation improvements, transportation
 17 services, and related technical support, within, and for, the City and County. Any hold
 18 harmless agreements which are unusual or significantly different from the standard provision,
 19 as determined by the City Attorney, would be separately approved by the Board of
 20 Supervisors.


