[Holland Court - Vacation]

ORDERING THE VACATION OF THE PUBLIC STREET EASEMENT OVER HOLLAND COURT NORTHWESTERLY OF HOWARD STREET BETWEEN 4TH STREET AND 5TH STREET AND A PORTION OF THE SOUTH SIDE OF MINNA STREET BETWEEN 4TH STREET AND 5TH STREET, ~~AND~~ ADOPTING FINDINGS PURSUANT TO CITY PLANNING CODE SECTION 101.1, AND INCORPORATING FINDINGS RELATING TO THE ISSUANCE OF A NEGATIVE DECLARATION.

Be it Ordained by the People of the City and County of San Francisco:

Section 1. Findings

The Board of Supervisors of the City and County of San Francisco hereby finds and declares as follows:

A. On July 19, 1999, the Board of Supervisors adopted Resolution No. 691-99, being a Resolution of Declaration of Intention to Order the Vacation of Holland Court and a portion of Minna Street owned in fee by the City.

B. The Clerk of the Board of Supervisors transmitted to the Department of Public Works a certified copy of said Resolution, and the Director of Public Works caused notice of adoption of said Resolution to be posted in the manner required by law.

C. When such matter was considered as scheduled by the Board of Supervisors at its special at Balboa High School ~~regular~~ meeting held ~~in City Hall~~, San Francisco, on August 16, 1999, beginning at 7:00 P.M., the Board heard all persons interested in said vacation.

1 D. From all the evidence submitted at the hearing on such Resolution, the Board of
2 Supervisors finds that the portion of the streets described in said Resolution is unnecessary for
3 present or prospective public use.

4 E. The public interest and convenience require that the vacation of the public street
5 easement be undertaken as declared in such Resolution No. 691-99. The Board of
6 Supervisors has jurisdiction to order such vacation.

7 F. By Planning Commission Motion Number 14557, a copy of which is on file in the
8 office of the Clerk of the Board of Supervisors in File No. 991193, the Planning
9 Department affirmed the decision to issue a Negative Declaration for the Project. The San Francisco
10 Board of Supervisors adopts as its own and incorporates by reference herein as though fully set forth,
11 the findings in the Planning Commission's Motion described above.

13 G. By Planning Commission Resolution Number 14559, a copy of which is on file in the
14 office of the Clerk of the Board of Supervisors in File No. 991193, the Planning
15 Department found that the proposed street vacation is in conformity with the City's General Plan,
16 including the street vacation and easement criteria in the Urban Design Element, and with the Eight
17 Priority Policies of City Planning Code Section 101.1. The San Francisco Board of Supervisors
18 adopts as its own and incorporates by reference herein as though fully set forth, the findings in the
19 Planning Commission's Resolution described above.
20

21 Section 2. The public street easement over Holland Court and a portion of Minna Street is
22 hereby ordered to be vacated as shown on Department of Public Works SUR Drawing Number 898,
23 dated April 27, 1999, a copy of which is on file in the office of the Clerk of the Board of Supervisors.


1 Section 3. The City, under the jurisdiction of the Department of Administrative Services,

7 official in connection with the subject matter hereof are hereby ratified, confirmed and approved by
8 this Board of Supervisors.




