10 Section 1. The Board of Supervisors hereby implements the provisions of the amendment to the  
11 Memorandum of Understanding within the authority of the Board of Supervisors between Teamsters,  
12 Local 856 and the City and County of San Francisco for Supervising Nurses for the period July 1,  
13 1998 through June 30, 2001 providing that all covered employees be placed into full retirement  
14 contribution status effective July 1, 1998 following approval of this ordinance by the Mayor. The  
15 provisions so implemented are on file in the office of the Board of Supervisors.


