

1 [Commending Vermont Supreme Court]

2 COMMENDING THE VERMONT SUPREME COURT'S RULING THAT THE STATE OF  
3 VERMONT IS CONSTITUTIONALLY REQUIRED TO EXTEND TO SAME-SEX COUPLES  
4 THE COMMON BENEFITS AND PROTECTIONS THAT FLOW FROM MARRIAGE UNDER  
5 VERMONT LAW.

7 WHEREAS, Lesbian and gay individuals and their family members do not enjoy the  
8 same legal recognition, rights, and protections as their heterosexual counterparts; and,

9 WHEREAS, One such example of this includes the inability to legally marry, which  
10 denies lesbian and gay individuals access to some 161 state and federal benefits; and,

11 WHEREAS, the City and County of San Francisco has long-established policies and  
12 procedures supporting and affirming lesbian, gay, bisexual, and transgender individuals and  
13 their right to register for and receive domestic partnership benefits; and,

14 WHEREAS, The issue of legalizing gay marriage has been and will continue to be  
15 litigated in courts across the country, and,

16 WHEREAS, In response to a legal challenge by three same-sex couples, the Vermont  
17 Supreme Court's ruled on December 20, 1999 that the state of Vermont is constitutionally  
18 required to extend to same-sex couples the common benefits and protections that flow from  
19 marriage under Vermont law; and,

20 WHEREAS, The court's decision further asserted that that denying same-sex couples  
21 access to the same rights and responsibilities as heterosexual married couples is  
22 discriminatory; and,

23 WHEREAS, This court also directed the state legislature to either legalize gay  
24 marriages or to decide how to bestow all of the previously denied rights and privileges of  
25 marriages to same sex couples,

6 commends the Vermont Supreme Court's ruling that the state of Vermont is constitutionally  
7 required to extend to same-sex couples the common benefits and protections that flow from  
8 marriage under Vermont law.
