12 WHEREAS, The Grants of Easement were recorded in the San Mateo County Recorders  
13 Office and subsequently, said property owners' requested that the City and County of San Francisco  
14 rescind the noise easements, and

16 WHEREAS, In accordance with Airport Commission Resolution No. 98-0070 and Resolution  
17 No. 99-0028, a copy of each which is on file with the Clerk of the Board of Supervisors in file no  
18 992303, the San Francisco Airport Commission recommends the rescission of said grants  
19 of easement by the delivery of quitclaim deeds to said property owners, now, therefore, be it


