

1 AUTHORIZING THE AIRPORT COMMISSION TO ACCEPT AND EXPEND A  
2 GRANT IN THE AMOUNT OF \$109,200 FROM THE BAY AREA AIR QUALITY  
3 MANAGEMENT DISTRICT (AIR DISTRICT) FOR ACQUISITION OF MEDIUM  
4 DUTY COMPRESSED NATURAL GAS (CNG) VEHICLES

7 WHEREAS, The Airport seeks to reduce vehicle emissions in the region and on  
8 terminal roadways; and

9 WHEREAS, The Air District assists public agencies in implementing emissions  
10 reduction projects, such as the addition of CNG vehicles to fleets; and

11 WHEREAS, The Airport Commission, in Resolution 98-0134, approved an  
12 application to seek, accept, and expend funds for this project; and

13 WHEREAS, The Airport would administer this grant, disburse incentive funds to  
14 permitted third party passenger carriers, and provide the Air District with information  
15 concerning the new vehicles; and

17 WHEREAS, No Airport funds would be used for the program, and the Airport  
18 would have no ownership interest in third party CNG vehicles; and

19 WHEREAS, This demonstration project would continue this Airport's reputation  
20 as a regional leader in promoting clean fuel use among ground transportation providers;  
21 now, therefore, be it

23 RESOLVED, That, pursuant to San Francisco Administrative Code §10.171, the  
24 Board of Supervisors does hereby authorize the Airport Commission to accept and  
25 expend funds awarded in this grant; and be it

2 indirect costs; and, be it


3 FURTHER RESOLVED, That although the City has incurred no legal




