**APPROVING**

~~REQUESTING THE BOARD OF SUPERVISORS TO APPROVE~~ A PARATRANSIT BROKER AGREEMENT WITH COMSIS MOBILITY SERVICES, INC., DBA INTELITRAN FOR AN AMOUNT NOT TO EXCEED ~~\$66,420,375~~ FOR A TERM OF FIVE YEARS  
**\$66,333,277**

WHEREAS, The City, through its Public Transportation Commission, has contracted out services to a Paratransit Broker, who manages subcontracts with paratransit service providers, monitors service quality, administers client eligibility, manages the sale of fare instruments, and acts as the principal customer service representative for paratransit services; and

WHEREAS, In 1991, the City entered into agreement with Cerenio Management Group to provide paratransit brokerage services for a period of four years and nine months, through June 30, 1996; this agreement was extended through June 30, 1999 to ensure a smooth implementation of the paratransit service requirements of the Americans with Disabilities Act (ADA), and further extended to March 31, 1999 to complete the process to select a new Broker; and

WHEREAS, The Public Transportation Department issued a Request for Proposals (RFP) to a nationwide pool of paratransit brokers to solicit bidders for the new contract period, and received three proposals in response to the RFP; and

WHEREAS, A Paratransit Broker Selection Committee, composed of three members of the Paratransit Coordinating Council, one transit professional outside of San Francisco, and one MUNI representative,

1 reviewed the proposals and conducted interviews with the two  
2 shortlisted proposers, Cerenio Management Group, and Comsis Mobility  
3 Services, Inc., dba Intelitran ("Intelitran"), and scored the  
4 proposals based on criteria set forth in the RFP; and

5 WHEREAS, MUNI negotiated with the winning proposer, Intelitran,  
6 to develop a contract that would ensure MUNI's continued delivery of  
7 ADA compliant and consumer-oriented paratransit services; and

8 WHEREAS, The Public Transportation Commission, pursuant to  
9 Resolution No. 00-003, a copy of which is on file with the  
10 clerk of the Board of Supervisors in file No. 000045, approved  
11 the selection of Intelitran as the new Paratransit Broker and  
12 authorized its General Manager to execute a Paratransit Broker  
13 Agreement with Intelitran, subject to the approval of the Board of  
14 Supervisors; now, therefore, be it

15 RESOLVED, That the Board of Supervisors approves the execution  
16 of a Paratransit Broker Agreement with Intelitran for the period of  
17 five years, beginning April 1, 2000 and ending March 31, 2005, at a  
contract amount not to exceed ~~\$66,420,375~~ for the term of the  
2/2/08 **\$66,333,277**




