

1 [Traffic Regulations]

2 ENACTING AND RESCINDING TRAFFIC REGULATIONS ON VARIOUS STREETS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
4 and the San Francisco Traffic Code, the following regulations governing the movement of  
5 vehicles are hereby enacted or rescinded as designated below:

6 **BICYCLE LANES - ESTABLISH**

7 Evans Avenue, both directions, between 3rd Street and Hunter's Point Boulevard  
8 Hunter's Point Boulevard, both directions, between Evans and Innes Avenues

9 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

10 Evans Avenue, south side, from Keith Street to a point 300 feet west of Middle  
11 Point Road  
12 Hunter's Point Boulevard, both sides, between Evans and Innes Avenues

13 **NO LEFT TURN - ESTABLISH**

14 Masonic Avenue, southbound, at McAllister Street

15 **NO LEFT TURN INTO DRIVEWAY - ESTABLISH**

16 Mission Street, westbound, approximately 225 feet east of 5th Street (at entrance  
to 5th and Mission Garage)

17 **TOW-AWAY, NO STOPPING BEFORE BALLPARK EVENTS - ESTABLISH**

18 Mariposa Street, south side, between Indiana and Tennessee Streets

19 **TOW-AWAY, NO STOPPING, 6 AM - 10 AM , MONDAY THROUGH FRIDAY -  
ESTABLISH**

20 Carl Street, south side, from 35 feet to 73 feet west of Cole Street (38-foot zone)

21 **NO TURN ON RED - ESTABLISH**

22 7th Street, northbound, at Market Street

23 **RIGHT LANE MUST TURN RIGHT - RESCIND**  
24 **RIGHT LANE MUST TURN RIGHT, EXCEPT MUNI - ESTABLISH**

25 Lake Merced Boulevard, westbound, at Middlefield Drive (adds Muni exemption)

Carl Street, south side, from 35 feet to 73 feet west of Cole Street (38-foot zone)

**NO TURN ON RED - ESTABLISH**

7th Street, northbound, at Market Street

**RIGHT LANE MUST TURN RIGHT - RESCIND**

**RIGHT LANE MUST TURN RIGHT, EXCEPT MUNI - ESTABLISH**

Lake Merced Boulevard, westbound, at Middlefield Drive (adds Muni exemption)




