9 WHEREAS, There is currently a shortage of after-school programs  
10 in San Francisco to promote healthy minds and bodies in San Francisco  
11 school children; and,

12 WHEREAS, Many parents and students in San Francisco have  
13 expressed support for the concept of a San Francisco Junior Tennis  
14 League as one such after-school program; and,

15 WHEREAS, The Tennis Advisory Board of the Department of  
16 Recreation and Parks has adopted a resolution supporting the  
17 establishment of a citywide San Francisco Junior Tennis League; and,

18 WHEREAS, The Presidio Middle School's Tennis Club provides San  
19 Francisco with a model for the establishment of after-school tennis  
20 programs throughout the City; and,

21 WHEREAS, The Presidio Middle School has begun a collaboration  
22 with the United States Tennis Association, the National Professional  
23 Tennis Association, the Youth Tennis Association, the San Francisco  
24 Unified School District, and the San Francisco Department of  
25 Recreation & Parks to work to marshal existing resources as well as

2 development, and operation of a San Francisco Junior Tennis League;

4 WHEREAS, The San Francisco Junior Tennis League is intended to  
5 provide opportunities to inner city youth extending beyond tennis and  
6 including mentoring, social intercourse and development, peer  
7 conflict resolution, team and school spirit, and the promotion of  
8 academic achievement and a healthy lifestyle; now therefore be it

9 RESOLVED, That the Board of Supervisors of the City and County  
10 of San Francisco hereby endorses the establishment of a citywide San  
11 Francisco Junior Tennis League; and be it,

12 FURTHER RESOLVED, That the Board of Supervisors of the City and  
13 County of San Francisco hereby urges the Department of Recreation and  
14 Parks to work collaboratively with the U.S. Tennis Association, the  
15 Youth Tennis Association, the National Junior Tennis League, the  
16 Professional Tennis Association, the San Francisco Unified School  
17 District, and other national and local organizations to bring tennis  
18 to San Francisco's children.
