7 WHEREAS, Willie Mays is generally regarded as the best all-around player in baseball  
8 history; and,

9 WHEREAS, Willie Mays wore a New York and San Francisco Giants uniform for 21  
10 seasons; and,

11 WHEREAS, Willie Mays holds more franchise career records than any other player,  
12 including games played, at-bats, runs, hits, doubles, and home-runs; and,

13 WHEREAS, "The Say Hey Kid" appeared in 24 All-Star Games, tied with Hank Aaron  
14 and Stan Musial for most career appearances; and,

15 WHEREAS, Inducted in the Hall of Fame in 1979, Mays was the ninth player inducted  
16 in the first year of eligibility; and,

17 WHEREAS, Willie Mays currently holds a lifetime contract with the San Francisco  
18 Giants as Special Assistant to the President, a position he has held since 1986, and appears  
19 at a number of civic and charitable events throughout the Bay Area on behalf of the Giants;  
20 now, therefore, be it

21 RESOLVED, That the Board of Supervisors of the City and County of San Francisco,  
22 in honor of the contributions that Willie Mays has made to the sport of baseball and to the city  
23 of San Francisco, does hereby urge the Port Commission to rename the south side of King  
24 Street bounded by Second and Third streets to 24 Willie Mays Plaza and request that the  
25 Department of Public Works erect double signage at this location.




