3 AUTHORIZING THE DEPARTMENT OF PUBLIC HEALTH, POPULATION HEALTH AND  
4 PREVENTION DIVISION, COMMUNITY SUBSTANCE ABUSE SERVICES, TO ACCEPT  
5 RETROACTIVELY AND EXPEND GRANT FUNDS OF \$367,942 FROM THE CALIFORNIA  
6 DEPARTMENT OF ALCOHOL AND DRUG PROGRAMS FOR THE DRUG COURT PARTNERSHIP  
7 PROGRAM AND TO ENTER INTO AN AGREEMENT WHICH DOES NOT INCLUDE PATENT  
8 INFRINGEMENT INDEMNIFICATION AND FALSE CLAIMS CLAUSES; PROVIDING FOR  
9 RATIFICATION OF ACTION PREVIOUSLY TAKEN.

10 WHEREAS, The Department of Public Health has applied for and been awarded a grant from  
11 The California Department of Alcohol and Drug Programs in the amount of \$367,942 for the Drug  
12 Court Partnership Program to provide viable alternatives to incarceration and addressing prison and  
13 jail overcrowding; and,

14 WHEREAS, As a condition of receiving the grant funds, The California Department of Alcohol  
15 and Drug Programs requires the City to enter into an agreement (the "Agreement"), a copy of which is  
16 on file with the Clerk of the Board of Supervisors in File No. 000145 ; and

17 WHEREAS, The Agreement does not contain certain provisions described below, which are  
18 required under the Administrative Code unless waived by the Board of Supervisors ; now, therefore,  
19 be it

20 RESOLVED, That the Department of Public Health is hereby authorized to accept  
21 retroactively and expend the grant funds pursuant to San Francisco Administrative Code section  
22 10.170-1; and, be it

23 FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement  
24 on behalf of the City; and, be it

enter into similar agreements with The California Department of Alcohol and Drug Programs if the  
grant recurs or is renewed.


