2 DIRECTING THE DEPARTMENT OF PARKING AND TRAFFIC AND THE DEPARTMENT OF  
3 PUBLIC WORKS TO COMMENCE WORK IMMEDIATELY ON TRAFFIC CIRCLES AND  
4 TRAFFIC CALMING MEASURES FOR URBANO DRIVE AT THE NORTHERN  
5 INTERSECTIONS OF VICTORIA AND CORONA AND TO COMPLETE THE WORK NO  
6 LATER THAN JUNE 15, 2000.

7 WHEREAS, On March 6, 2000, 27-year old Christopher Litz was  
8 severely injured in a hit-and-run accident by an automobile driven at  
9 an excessive speed down the 100 block of Urbano Drive; and,

10 WHEREAS, Mr. Litz remains in critical condition at San Francisco  
11 General Hospital while the driver of the vehicle remains at large;  
12 and,

13 WHEREAS, Neighbors along Urbano Drive and throughout the  
14 Ingleside Terraces neighborhood have complained about unsafe driving  
15 and excessive speeding along Urbano Drive for years; and,

16 WHEREAS, Neighbors have made repeated requests for traffic  
17 circles and traffic calming measures, as well as greater enforcement  
18 measures to ensure pedestrian safety on Urbano Drive; and,

19 WHEREAS, The Department of Parking and Traffic and the  
20 Department of Public Works have surveyed the site and agreed that  
21 traffic circles are appropriate traffic calming measures on Urbano  
22 Drive; now therefore be it,

23 RESOLVED, That the Board of Supervisors of the City and County  
24 of San Francisco hereby urges the Department of Parking and Traffic  
25 and the Department of Public Works to commence work immediately on




