5 WHEREAS, Affordable housing is a big problem in San Francisco for youth, as well as  
6 other San Franciscans; and,

7 WHEREAS, The San Francisco Youth Commission is charged with identifying the  
8 concerns and needs of San Francisco's youth and making recommendations addressing  
9 those concerns; and,

10 WHEREAS, Youth Advocacy Day is an annual event sponsored by the San Francisco  
11 Youth Commission where Bay Area youth receive training on the legislative process and  
12 important youth issues and meet with state legislators to make youth concerns known, with  
13 the goal of increasing the legislators' understanding of youth issues and contributing to the  
14 passage of important bills for youth; and,

15 WHEREAS, Youth Advocacy Day offers a unique educational experience for youth to  
16 learn more about government, how to fight for what they believe in, and how to talk to  
17 legislators; and,

18 WHEREAS, Youth Advocacy Day offers State Legislators the rare opportunity to hear  
19 directly from youth and the Youth Commission is committed to providing a stronger voice for  
20 youth; and,

21 WHEREAS, Youth Advocacy Day offers youth the opportunity to voice their opinions  
22 on issues concerning affordable housing which affect youth; and,

23 WHEREAS, This year's Youth Advocacy Day is devoted to advocating for the  
24 construction and preservation of affordable housing in California; now, therefore, be it

1           RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
2 authorizes the San Francisco Youth Commission's participation in Housing Youth Advocacy  
3 Day on May 24, 2000 in Sacramento; and, be it

5 Youth Commission for its leadership and involvement in Housing Youth Advocacy Day.
