AUTHORIZING THE DEPARTMENT OF PUBLIC HEALTH, COMMUNITY HEALTH NETWORK, PRIMARY CARE, TO ACCEPT RETROACTIVELY AND EXPEND A GRANT IN THE AMOUNT OF \$370,185 FROM THE COMMUNITY ENDOWMENT, FOR THE PARTNER SUPPORT PROGRAM II AT BALBOA HIGH SCHOOL AND TO ENTER INTO AN AGREEMENT WHICH DOES NOT INCLUDE INTELLECTUAL PROPERTY INDEMNIFICATION AND FALSE CLAIMS CLAUSES; PROVIDING FOR RATIFICATION OF ACTION PREVIOUSLY TAKEN.

WHEREAS, The Department of Public Health, Community Health Network, has applied for and been awarded a grant from The California Endowment in the amount of \$370,185, for the Partner Support Program II; and,

WHEREAS, As a condition of receiving the grant funds, The California Endowment requires the City to enter into an agreement (the “Agreement”), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 000353 ; and,

WHEREAS, The Agreement does not contain certain provisions described below, which are required under the Administrative Code unless waived by the Board of Supervisors; now, therefore, be it

RESOLVED, That the Department of Public Health is hereby authorized to accept retroactively and expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and, be it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement on behalf of the City; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement contained in Sections 21.21 of the Administrative Code that the Agreement include an indemnification of the City by The California Endowment for the infringement of patent rights, copyright, trademark, and other intellectual property rights; and, be it


FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement that the Agreement include a paragraph reciting the false claim provisions contained in Section 21.35 of the Administrative Code; and, be it




FURTHER RESOLVED, The Controller should be urged to designate the positions created under the grant as a "G" or grant-funded positions, which would terminate when the grant expires.


