2 DESIGNATING CERTAIN INTERSECTIONS AS "STOP" INTERSECTIONS.

3 RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the
4 following intersections are hereby designated as "Stop" intersections, and the Department
5 of Parking and Traffic is hereby authorized and directed to cause "Stop" signs to be
6 installed thereat as designated below:

7 STOP SIGNS - ESTABLISH

8 24th and Rhode Island Streets, northeast and southwest corners, stopping 24th
9 Street (makes this uncontrolled intersection a two-way STOP)

10 Curtis and Morse Streets (east intersection), northeast and northwest corners,
11 stopping westbound Morse Street and southbound Curtis Street

12 Curtis and Morse Streets (west intersection), southeast and southwest corners,
13 stopping eastbound Morse Street and northbound Curtis Street

14 Joost and Ridgewood Avenues, northeast and southwest corners, stopping Joost
15 Street (makes this uncontrolled intersection a two-way STOP)

16 Newton and Morse Streets, northwest and southeast corners, stopping Newton
17 Street (makes this an all-way STOP)

Newton and Morse Streets, northwest and southeast corners, stopping Newton Street (makes this an all-way STOP)




