2 URGING THE SAN FRANCISCO BOARD OF EDUCATION AND THE SAN FRANCISCO
3 UNIFIED SCHOOL DISTRICT TO CONSIDER RENAMING BUENA VISTA ELEMENTARY
4 SCHOOL THE SANTANA SPANISH LANGUAGE K-8 ALTERNATIVE SCHOOL.

6 WHEREAS, Carlos Santana was born and raised in Mexico where he
7 was introduced to traditional music and music theory and played
8 guitar in local bands; and,

9 WHEREAS, Carlos and his family moved to San Francisco in 1960,
10 and here he continued to develop his unique musical style combining
11 blues, rock and Afro-Cuban rhythms; and,

12 WHEREAS, The music of Carlos Santana transcends cultural and
13 language barriers, drawing in peoples from throughout the world; and,

14 WHEREAS, In 1997, Carlos Santana was inducted into the Bammy
15 Hall of Fame and this year he received eight Grammy Awards for his
16 album "Supernatural",; and

17 WHEREAS, The Milagro Foundation, founded by Carlos and Deborah
18 Santana, provides financial assistance for the educational, medical
19 and housing needs of children; and

20 WHEREAS, The San Francisco Board of Education names schools or
21 buildings after individuals who have made outstanding contributions
22 to the country or community or who have made contributions of state,
23 national or worldwide significance; and

1 WHEREAS, Given his outstanding musical accomplishments and his
2 contributions to the community, it is appropriate to consider naming
3 a school after Carlos Santana; now, therefore, be it

4 RESOLVED, That the Board of Supervisors of the City and County
5 of San Francisco urges the San Francisco Board of Education and the
6 San Francisco Unified School District to consider renaming Buena
7 Vista Elementary School the Santana Spanish Language K-8 Alternative
8 School; and, be it

9 FURTHER RESOLVED, That a copy of this resolution be forwarded to
10 his Honor, the Mayor, with a request that he transmit copies to the
11 President of the Board of Education as well as to the Superintendent
12 of the Unified School District.


