

1 [Accept-expend State Grant]

2 AUTHORIZING THE DISTRICT ATTORNEY OF THE CITY AND COUNTY OF
3 SAN FRANCISCO TO RETROACTIVELY ACCEPT AND EXPEND A GRANT IN
4 THE AMOUNT OF \$120,000 FROM THE OFFICE OF CRIMINAL JUSTICE
5 PLANNING FOR A PROJECT ENTITLED "ELDER ABUSE VERTICAL
6 PROSECUTION PROGRAM".

7 WHEREAS, The District Attorney and the City and County
8 of San Francisco desire to undertake a project designated
9 the Elder Abuse Vertical Prosecution Program (EA-VP) to be
10 funded and administered by the California Office of
11 Criminal Justice Planning (OCJP) in accordance with the
12 California Penal Code Section 368 (California Elder abuse
13 Statute), and

14 WHEREAS, The District Attorney proposes to maximize
15 use of available grant funds on program expenditures by not
16 including indirect costs in the grant budget; now
17 therefore, be it

18 RESOLVED, That the Board of Supervisors hereby waives
19 inclusion of indirect costs in the grant budget, and be it

20 FURTHER RESOLVED, That the District Attorney of the
21 City and County of San Francisco, is authorized to submit
22 retroactively the attached Grant Award Application to the
23 California Office of Criminal Justice Planning and is
24 authorized to execute on behalf of the City and County of
25 San Francisco the attached Grant Award for Elder Abuse
Supervisors Teng, Becerril

1 Prosecution purposes, and be it

2 FURTHER RESOVLED, That the grant funds received hereunder
3 shall not be used to supplant local funds that would, in the
4 absence of the Elder Abuse Vertical Prosecution Program be
5 made available to support the prosecution of elder abuse; and


6 BE IT FURTHER RESOLVED, that it is agreed that any
7 liability arising out of the performance of this Grant
8 Award contract including Civil Court actions for damages
9 shall be the responsibility of the grantee and the
10 authorizing agency. The State of California and OCJP
11 disclaim responsibility for any such liability; and

12 THEREFORE, IT IS HEREBY RESOLVED, that the District
13 Attorney of the City and County of San Francisco is
14 authorized to retroactively apply for, accept and expend
15 funds made available through the Office of Criminal Justice
16 Planning for the project entitled Elder Abuse Vertical
17 Prosecution Program (EA-VP) in the amount of \$120,000 for
18 Elder Abuse Prosecution purposes for the twelve month
19 period April 1, 2000 through March 31, 2001, and waiving
20 indirect cost due to funding constraints.


