2 RESOLUTION DETERMINING THAT THE ISSUANCE OF A TYPE 20 OFF-SALE  
3 BEER AND WINE ALCOHOLIC BEVERAGE CONTROL LICENSE TO PAUL  
4 FROHLICH, FOR "YUM" LOCATED AT 1750 MARKET STREET, WILL SERVE THE  
5 PUBLIC CONVENIENCE AND NECESSITY OF THE PEOPLE OF THE CITY AND  
6 COUNTY OF SAN FRANCISCO, IN ACCORDANCE WITH SECTION 23958.4 OF THE  
7 CALIFORNIA BUSINESS AND PROFESSIONS CODE; WITH CONDITIONS.

9 WHEREAS, Paul Frohlich is seeking issuance of a Type 20 off-sale beer and  
10 wine alcoholic beverage control license for "Yum", located at 1750 Market Street; and,

11 WHEREAS, The City Planning Department has verified that the area is properly  
12 zoned; and

13 WHEREAS, The Police Department recommends that the liquor license  
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 20  
18 off-sale beer and wine alcoholic beverage control license, to Paul Frohlich for "Yum",  
19 located at 1750 Market Street will serve the public convenience and necessity of the  
20 people of the City and County of San Francisco.

21 Conditions: 1) Sales of alcoholic beverages shall be permitted only between the  
22 hours of 11:00 a.m. and 8:00 p.m. each day of the week. 2) No malt beverage products  
23 shall be sold, regardless of container size, in quantities of less than six per sale.


