

1 [Supporting SB 2021]  
2 SUPPORTING SB 2021, WHICH WOULD ALLOW A TAX CREDIT OF \$500 FOR EACH  
3 EMPLOYEE PLACED ON AN ALTERNATIVE WORK SCHEDULE COMPRISED OF  
4 TELECOMMUTING, COMMUTING DURING NON-PEAK HOURS, FLEXTIME, AND  
5 WEEKEND WORKDAYS.

6 WHEREAS, The City and County of San Francisco is committed to improving the  
7 quality of the environment for San Franciscans; and,

8 WHEREAS, According to Caltrans, Californians spend more than 400,000 hours  
9 commuting during each workday; and,

10 WHEREAS, Commuter traffic results in more than 192,000 gallons of fuel consumed  
11 and nearly 15,000 tons of emissions; and,

12 WHEREAS, Senate Bill 2021, proposed by Assembly member Richard Polanco, would  
13 provide a tax incentive to companies that are able to schedule workers on alternative shifts  
14 upon mutual agreement with those workers; and,

15 WHEREAS, Because it applies to workers living more than 9 miles from their  
16 workplace, this bill promises to reduce traffic congestion and improve air quality; now,  
17 therefore, be it

18 RESOLVED, That the San Francisco Board of Supervisors does hereby support and  
19 urge the passage of SB 2021, which would allow a tax credit of \$500 for each employee  
20 placed on a an alternative work schedule comprised of telecommuting, commuting during  
21 non-peak hours, flextime and weekend workdays; and, be it,

22 FURTHER RESOLVED, That copies of this legislation be sent to our state  
23 representatives, to His Honor the Mayor Willie Brown's Legislative Office, and to  
24 Governor Gray Davis.


