

1 [COMMENDATION]

2 COMMENDING BAYVIEW HUNTERS POINT COMMUNITY BEACON, SECOND HARVEST,
3 CONAGRA INC., THE SAN FRANCISCO FOOD BANK, AND THE DEPARTMENT OF
4 CHILDREN, YOUTH, & THEIR FAMILIES FOR THEIR WORK IN DEVOLOPING A KIDS
5 CAFE IN SAN FRANCISCO.

6 WHEREAS, It is estimated that one in five children in San Francisco is at risk of going
7 hungry; and,

8 WHEREAS, A 1998 study done by Tufts University Center on Hunger and Poverty
9 indicates that even mild malnutrition experienced by young children during critical periods of
10 growth may lead to reduction in physical growth and affect brain development; and,

11 WHEREAS, Bayview Hunters Point Community Beacon, Second Harvest, ConAgra Inc.,
12 the San Francisco Food Bank, and the Department of Children, Youth, & Their Families have
13 collaborated to bring a Kids Cafe (a program Second Harvest developed and implemented in
14 more than 250 sites) to San Francisco; and,

15 WHEREAS, The Kids Cafe provides twenty students with instruction in nutrition and meal
16 planning and also fuses math and sociology principles into the context of food preparation; and,

17 WHEREAS, Every Monday through Thursday, the youth at Kids Cafe serve 60 to 100
18 children ages 5 through 16 who might otherwise have to skip dinner; and,

19 WHEREAS, The students at Kids Cafe have also served over 200 meals to the elderly in
20 the Bayview Hunters Point Community; and

21 WHEREAS, Every month, the students focus on the food and culture of a different ethnic
22 group; now, therefore be it


