

1 **APPROVING EMERGENCY WORK AND CONTRACT OF THE PURBLIC**
2 **TRANSPORTATION DEPARTMENT FOR THE REPAIR OF THE MONTGOMERY**
3 **SUBSTATION DUCTBANK AND INSTALLATION OF POWER FEEDERS AND**
4 **RATIFYING APPROVING ACTIONS BY THE DEPARTMENT TO DATE ON SUCH WORK**
5 **AND CONTRACT.**

6 **WHEREAS,** The power feeders and ductbank below Market Street are damaged,
7 jeopardizing the continuous flow of power to the Montgomery subway station; and

8 **WHEREAS,** The loss of power would greatly impair subway service between the Powell and
9 Embarcadero substations; and

10 **WHEREAS,** This emergency work is required to prevent the imminent loss of essential
11 public services; and

12 **WHEREAS,** The work to be performed includes the design and necessary repairs to the
13 ductbank and the installation of power feeders; and

14 **WHEREAS,** The Public Transportation Department is currently evaluating the extent of
15 damage and developing plans for repairs; and

16 **WHEREAS,** The Department currently estimates that the cost of the emergency work is
17 approximately \$490,000; and

18 **WHEREAS,** The project is funded by 80% Federal Section 5307 Grants and 20% Bridge
19 Tools; and

20 **WHEREAS,** Chairman H. Welton Flynn of the Municipal Transportation Agency approved
21 the emergency work and contract on March 9, 2000 by a signed declaration, a copy of which is on
22 file with the Clerk of the Board of Supervisors in File No. 000684; and

23 **WHEREAS,** On April 4, 2000, pursuant to Municipal Transportation Agency Resolution No.
24 00-036, a copy of which is on file with the Clerk of the Board of Supervisors in File No.
25 000684, the Municipal Transportation Agency ratified and approved actions taken to date and


