1 [FEDERAL FUNDING - COMMUNITY DEVELOPMENT]  
2 APPROVING THE 2000 COMMUNITY DEVELOPMENT PROGRAM. AUTHORIZING THE  
3 MAYOR, ON BEHALF OF THE CITY AND COUNTY OF SAN FRANCISCO, TO ACCEPT AND  
4 EXPEND THE CITY'S 2000 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)  
5 ENTITLEMENT FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN  
6 DEVELOPMENT, AND PROGRAM INCOME GENERATED BY THE SAN FRANCISCO  
7 REDEVELOPMENT AGENCY UP TO \$33,734,275 WHICH INCLUDE INDIRECT COSTS OF  
8 \$160,000; AND APPROVING EXPENDITURE SCHEDULES FOR RECIPIENT DEPARTMENTS  
9 AND AGENCIES AND FOR INDIRECT COSTS; AND PLACING \$533,581 ON RESERVE; AND  
10 PLACING \$100,000 FOR ASIAN INC. ON BOARD RESERVE.

11 WHEREAS, under Title I of the Housing and Community Development Act of 1974, as  
12 amended, and related Federal regulations, San Francisco is eligible to receive a Community  
13 Development Block Grant; and

14 WHEREAS, the Mayor's Office of Community Development has prepared programs entitled  
15 Final Recommendations for the 2000 Community Development Block Grant, and the Expenditure  
16 Schedules for an anticipated entitlement, and reprogrammed funds from prior year Community  
17 Development Programs and program income generated by the Mayor's Office of Community  
18 Development and the San Francisco Redevelopment Agency as needed, up to \$33,734,275; and

19 WHEREAS, the City will receive \$24,925,000 in 2000 CDBG Program funds; and

20 WHEREAS, a Preliminary Environmental Record on the Final Proposal has been prepared; and

22 WHEREAS, the Certifying Officer shall follow procedural provisions of NEPA and CEQA to  
23 make certain that all projects are in compliance with the applicable state and federal provisions and  
24 requirements; now, therefore, be it

1 RESOLVED, that the Board of Supervisors does hereby approve the Final Proposal 2000  
2 Community Development Block Grant, to accept and expend the City's 2000 Community  
3 Development Block Grant Entitlement from the U.S. Department of Housing and Urban Development,  
4 transfer and expend reprogrammed funds from prior year Community Development Programs up to  
5 \$25,275,000 and an estimated \$8,459,275 in program income generated by the Mayor's Office of  
6 Community Development, the Mayor's Office of Housing and the San Francisco Redevelopment  
7 Agency, and authorizes the Mayor to enter into and execute contract agreements between the City and  
8 County of San Francisco and departments identified in the 2000 Community Development Program;  
9 and, be it

10 FURTHER RESOLVED, that the Board of Supervisors does hereby authorize the Mayor to  
11 enter into and execute a contract between the City and County of San Francisco and the San Francisco  
12 Conservation Corps; and, be it

13 FURTHER RESOLVED, that the City's Annual Salary Ordinance be amended to reflect the  
14 staffing identified in the expenditure schedule; and, be it

15 FURTHER RESOLVED, that indirect costs of \$160,000 have been included in this grant; and,  
16 be it

17 FURTHER RESOLVED, that the Mayor is hereby authorized to submit documentation and  
18 certifications required by the U.S. Department of Housing and Urban Development; and, be it

19 FURTHER RESOLVED, that the Board of Supervisors does hereby place funds in the amount  
20 of \$533,581 on reserve pending budget details of specific proposals, to be released by the Finance and  
21 Labor Committee ; and, be it

22 FURTHER RESOLVED, that the Board of Supervisors does hereby place  
funds in the amount of \$100,000 for Asian Inc. on reserve with the  
Mayor's Office of Economic Development, to be released by the Board of  
Supervisors.
