

[GRANT - State Funds]

1 AUTHORIZING THE SAN FRANCISCO PUBLIC DEFENDER'S OFFICE TO ACCEPT AND
2 EXPEND \$98,857 AWARDED BY THE OFFICE OF CRIMINAL JUSTICE PLANNING
3 (OCJP) AS PART OF THE ONGOING VERTICAL DEFENSE OF INDIGENTS PROGRAM
4 TO HELP CREATE A SEPARATE UNIT TO HANDLE MAJOR FELONY CASES IN SAN
5 FRANCISCO.

6 WHEREAS, the San Francisco Public Defender's Office has a
7 mission to represent indigent defendants accused of criminal
8 offenses;

9 WHEREAS, the San Francisco Public Defender's Office has been
10 selected to receive \$ 98,857 to undertake a certain project
11 designated as the Vertical Defense of Indigents (VDI) Major Felonies
12 Unit to be funded in part from funds made available through the
13 Vertical Defense of Indigents Program administered by the Office of
14 Criminal Justice Planning (hereafter referred to as OCJP).

15 NOW, THEREFORE, BE IT RESOLVED that the Public Defender of the
16 City and County of San Francisco is authorized, on its behalf to
17 submit the attached proposal to OCJP and is authorized to sign and
18 approve on behalf of the Board of Supervisors the attached Grant
19 Award Agreement including any extensions or amendments thereof.

20 BE IT FURTHER RESOLVED that the Public Defender is authorized
21 to accept and expend \$ 98,857 for the grant funds for the vertical
22 defense of indigent program, waiving indirect costs;

23 IT IS AGREED that any liability arising out of the performance
24 of this Grant Award Agreement, including civil court actions for
25 damages, shall be the responsibility of the grant recipient and
authorizing agency. The State of California and OCJP disclaim



responsibility for such liability.


1 BE IT FURTHER RESOLVED that grant funds received hereunder


