3 ADOLESCENT HEALTH 2000 AND DECLARING MAY 4 - 5, 2000 "ADOLESCENT HEALTH  
4 DAYS" IN THE CITY AND COUNTY OF SAN FRANCISCO.

6 WHEREAS, The San Francisco Adolescent Health Working Group is a coalition of  
7 multidisciplinary health providers, program administrators, lawyers, youth advocates, and  
8 representatives from local and state CHDP/EPST and Medi-Cal managed care plans; and,

9 WHEREAS, The goal of the San Francisco Adolescent Health Working Group is to  
10 improve the health and well-being of youth, families, and communities by assuring that  
11 adolescents have easy access to culturally-, age-, and developmentally-appropriate health  
12 and youth development services; and,

13 WHEREAS, The San Francisco Adolescent Health Working Group is sponsoring its  
14 second adolescent health conference, Adolescent Health 2000, a Bay Area conference for  
15 health and youth professionals, administrators, and advocates; and,

16 WHEREAS, Youth development is an asset-building approach that recognizes,  
17 encourages, and reinforces the strengths and capabilities of young people; and,

18 WHEREAS, Adolescent Health 2000 will focus on the integration of youth development  
19 principles into adolescent health practice; now, therefore, be it

20 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
21 commends the San Francisco Adolescent Health Working Group and Adolescent Health  
22 2000; and, be it

23 FURTHER RESOLVED, That the Board declares May 4-5, 2000 "Adolescent Health  
24 Days" in the City and County of San Francisco.


