8 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
9 does hereby appoint hereinafter designated persons to serve as members of the
10 Transgender Civil Rights Implementation Task Force, pursuant to the provisions of Resolution
11 No. 102-00, for the term specified:

12 Claire Skiffington, vacant seat, (Seat No. 1, must be a member of the transgender
13 community), new two-year term ending June 1, 2002;

14 Theresa Sparks, vacant seat, (Seat No. 2, must be a member of the transgender
15 community), new two-year term ending June 1, 2002;

16 Jordy Jones, vacant seat, (Seat No. 3, must be a member of the transgender
17 community), new two-year term ending June 1, 2002;

18 Sarah Marshall, vacant seat, (Seat No. 4, must be a member of the transgender
19 community) new two-year term ending June 1, 2002;

20 Riley Morgan, vacant seat, (Seat No. 5, must be a member of the transgender
21 community), new two-year term ending June 1, 2002;

22 David Cameron Strachan, vacant seat, (Seat No. 6, must be a member of the
23 transgender community), new two-year term ending June 1, 2002;

24 Matthew Martin, vacant seat, (Seat No. 7, must be a member of the transgender
25 community), new two-year term ending June 1, 2002;

1 L. J. Irving, vacant seat, (Seat No. 8, must be a member of the transgender
2 community) new two-year term ending June 1, 2002;

3 Jo Ellen Fisher, vacant seat, (Seat No. 9, must be a member of the transgender
4 community), new two-year term ending June 1, 2002;

5 Shawna Virago, vacant seat, (Seat No. 10, must be a member of the transgender
6 community), new two-year term ending June 1, 2002;

7 Dominique Rosa Leslie, vacant seat, (Seat No. 11, must be a member of the
8 transgender community), new two-year term ending June 1, 2002.

9 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 10 1. The membership of the Transgender Civil Rights Implementation Task Force has a
11 goal to be representative of the diversity of the City and County of San Francisco.
- 12 2. Applicants Sarah Marshall and Riley Morgan, new appointees, who are not
13 residents of San Francisco, are persons with experience that uniquely qualifies
14 them to serve on the Transgender Civil Rights Implementation Task Force.
- 15 3. The Transgender Civil Rights Implementation Task Force has attempted to fill the
16 positions, for which Sarah Marshall and Riley Morgan were nominated, with
17 individuals who are City residents and who have the specific experience, skills, and
18 qualifications, but has been unable to do so at this time. The Rules Committee has
19 certified that Sarah Marshall and Riley Morgan are qualified to serve on the
20 Transgender Civil Rights Implementation Task Force.
- 21 4. After exercising due diligence, the Board of Supervisors concludes that there is no
22 other possible representative, who is a resident of San Francisco and who has the
23 specific experience, skills, or qualifications possessed by these applicants, and who
24 are willing to serve on the Transgender Civil Rights Implementation Task Force at
25 this time; and, be it

1 FURTHER RESOLVED, That the Board of Supervisors waives the residency
2 requirement for Sarah Marshall and Riley Morgan, as allowed in cases where no qualified
3 City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that
4 requires persons appointed to boards, commissions, and advisory bodies established by
5 legislative act of the Board of Supervisors to be residents of the City and County of San
6 Francisco.




