

1 [Emergency Repair]

2 **AUTHORIZING EXPENDITURE OF FUNDS FOR EMERGENCY REPAIR OF**
3 **CORROSION IN SAN JOAQUIN PIPELINE NO. 3 OF THE HETCH HETCHY**
4 **AQUEDUCT.**

5 WHEREAS, examination and materials testing on San Joaquin
6 Pipeline No. 3 of the Hetch Hetchy Aqueduct has revealed serious
7 corrosion that could lead to a pipeline rupture; and,

8 WHEREAS, such a pipeline rupture could lead to a pipeline
9 collapse endangering adjacent, parallel pipelines and the
10 foundation of the Hetch Hetchy Moccasin-Newark Transmission
11 Line;

12 WHEREAS, such a pipeline rupture will threaten the health
13 and safety of the citizens of San Francisco and other Bay Area
14 communities due to a massive reduction in water supply for an
15 indeterminate period of time; and,

16 WHEREAS, on November 19, 1999, the President of the Public
17 Utilities Commission, in accordance with San Francisco
18 Administrative Code Article IV, §6.60, declared the existence of
19 an emergency condition requiring immediate repairs to San
20 Joaquin Pipeline No. 3 of the Hetch Hetchy Aqueduct to prevent
21 or mitigate loss of, or damage to life, health, property or
22 essential public services; and,

23 WHEREAS, by Resolution 00-0079 of March 14, 2000, the
24 Public Utilities Commission ratified the November 19, 1999
25 Declaration of Emergency made by the President of the Commission

1 and requested the Board of Supervisors approve the expenditure
2 of four million two hundred ten thousand dollars (\$4,210,000.00)
3 to repair San Joaquin Pipeline No. 3; and

4 WHEREAS, funding for the repairs is currently available in
5 Hetch Hetchy Project No. CUH762 San Joaquin Pipeline Repair;
6 now, therefore, be it

7 RESOLVED, that the Board of Supervisors approves the
8 emergency expenditure of four million two hundred ten thousand
9 dollars (\$4,210,000.00) for repair of San Joaquin Pipeline No. 3
10 of the Hetch Hetchy Aqueduct.


