12 with free meals during the summer months from June 2000 to  
13 August 2000; and,

14 WHEREAS, an average of 4,000 children are served meals  
15 each day during the summer at 80 meal sites throughout the  
16 City; and,

17 WHEREAS, the grant terms prohibit including indirect  
18 costs in the grant budget; now, therefore, be it

19 RESOLVED, that the Board of Supervisors hereby waives  
20 inclusion of indirect costs in the grant budget; and be it



24 funds in the amount of \$528,000 from the United States


